

Pastor of the Month

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE A PARTICIPANT'S CHANCES OF WINNING.

CONTEST DESCRIPTION:

The Pastor of the Month contest ("Contest") will begin on April 5, 2021 and end at 11:59pm on April 19, 2021 ("Contest Period"). This Contest will be conducted exclusively online. One (1) grand prize winner will be awarded the following: a Pastor of the Month Plaque that will be presented during their Sunday service by a WNNL-FM on-air personality. (ARV \$50) See below for further details.

HOW TO ENTER:

Listeners of WNNL-FM ("Station") who are legal residents of the United States residing within the Raleigh, NC metropolitan area and are 21 years of age or older will be able to take part in this Contest. To participate in the Contest, participants must do the following:

1. To enter, contest participants must register online and upload one (1) photograph of their pastor; along with a brief essay of 300 words or less that describes why their pastor should be selected to be the Pastor of the Month.
2. Contestants must submit their entries online through the Station's website at www.thelightnc.com.
3. Upon entering the website, participants are to follow the on-screen instructions for the online entry form, including entering their name, date of birth, address, phone number, email address, and any optional or additional contact information as requested, to register for a chance to win.
4. All Internet entries must be received by 11:59pm local time on January 17th, February 7th, March 7th, April 11th, May 9th, June 6th, July 11th, August 8th, September 12th, October 10th, November 7th and December 12th, or they will be void.
5. One entry per person per day per email address during the Contest Period.
6. Entries will be posted online for public voting. Online voting will take place beginning on January 18th, February 9th, March 8th, April 12th, May 10th, June 7th, July 12th, August 9th, September 13th, October 11th, November 8th and December 13th and will end at 11:59pm local time on January 24th, February 14th, March 14th, April 18th, May 16th, June 13th, July 18th, August 15th, September 19th, October 17th, November 14th and December 19th ("Voting Period").
7. One (1) vote per person during the Voting Period. Any attempt by entrant and/or his/her family/friends to vote more than the number of times authorized by using multiple names or email address and/or any other fraudulent mechanism, as determined by the Station in its sole discretion, shall give the Station the right to disqualify the entrant in its reasonable discretion.

8. In the event of a dispute regarding the identity of a participant's online entry, the entry will be deemed to have been made by the authorized holder of the e-mail account at the time the entry was made.
9. Submitted entries must be "family friendly", appropriate for all audiences, and must meet the below-listed Entry Requirements.
10. By uploading a submission and entering this Contest, each participant represents and warrants to be bound by these Official Contest rules, and that they are authorized to and have the rights to submit the content within the entry.

Entry Requirements: Entry may **not** contain, as determined by the Station, in its sole discretion, any content that:

- is patently offensive, illegal, pornographic or obscene, or similarly inappropriate in the Station's sole discretion.
- contains any profanity, obscene language, lewd or sexual content or references, contains nudity.
- contains trademarks, logos, or trade dress (such as distinctive packaging or building exteriors/interiors) owned by others, without permission; contains any personal identification, such as license plate numbers, personal names, e-mail addresses or street addresses;
- is not produced and solely owned by the contestant submitting the entry
- contains commercial products (e.g., clothing, toys, food) and/or their trademarks, brands, logos or endorsements
- has been published and has been submitted in other competitions
- contains derogatory characterizations of any ethnic, racial, sexual or religious groups, humiliate other people (publicly or otherwise), or otherwise assault or threaten others
- promotes alcohol, illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing); promotes any activities that may appear unsafe or dangerous; promotes any particular political agenda or message;
- contains look-alikes of celebrities or other public or private figures, living or dead
- contains materials embodying the names, likenesses, voices, or other distinctive indicators identifying any person, including, without limitation, celebrities and/or other public or private figures, living or dead, without permission
- violates any law
- If individuals in addition to the contestant are featured in the entry, each entrant warrants and represents that the entrant has obtained permission from each person who appears in the submission

EXECUTION:

1. During the Contest Period, eligible participants will be encouraged to take part in the Contest by registering online at www.thelightnc.com. After completing the registration process, qualified entrants will be eligible for a chance to win.
2. One (1) winner will be determined by the amount of votes the nominee receives from their WNNL-FM online peers/users. The nominee that receives the highest number of votes will be deemed the Pastor of the Month.
3. On or about January 24^h, February 15th, March 15th, April 19th, May 17th, June 14th, July 19th, August 16th, September 20th, October 18th, November 15th and December 20th, 2021, one (1) winner will be determined at the sole discretion of Station personnel

who will select the winner from among all eligible entries receiving the highest number of online votes.

4. The grand prize winner will be notified by phone, and / or e-mail.
5. Entrants agree to be bound by the terms of these Official Rules and by the decisions of Station management which will be final and binding in all matters pertaining to this Contest.

ELIGIBILITY RESTRICTIONS:

1. The Contest is open only to legal residents of the United States residing within the Raleigh, NC metropolitan area who are 21 years of age or older as of the commencement date of the Contest.
2. Employees of the Station, Radio One of Raleigh, its officers, directors, subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, members of the immediate families, and members of the households (whether related or not) of any of the above are NOT eligible to participate or win in this Contest. For purposes of this Contest, immediate family members mean spouses, parents, grandparents, children, and siblings and their respective spouses.
3. Persons who have won a prize in another contest or promotion of any kind from the Station within the thirty (30) day period immediately preceding the start date of this Contest are not eligible to participate. Only one person per family or household (whether related or not) may win in any promotion from the Station during any thirty (30) day period.
4. Contestants agree to abide with any applicable federal, state, local laws and regulations.

PRIZES:

1. Grand Prize package will include the following:
 - a. One (1) grand prize winner will be awarded the following: a Pastor of the Month Plaque that will be presented during their Sunday service by a WNNL-FM on-air personality. (ARV \$50)
2. No substitution of prize is offered, no transfer of prize to a third party is permitted and non-cash prizes may not be redeemed for cash value, except as determined by Station management and/or the sponsor in its sole discretion. The Station reserves the right to substitute an item of equal or greater value in the event an advertised prize element is unavailable.
3. All cash prizes won will be awarded in the form of a check. Winners will be notified when their prize check is available for pick-up.
4. Gift cards are subject to terms and conditions specified by issuer.
5. Prizes will be awarded only upon winner verification and final approval by the Station.

6. To the extent that prize elements are provided by third-party providers, winner agrees to look solely to applicable prize providers with respect to any claims, losses, or disputes in connection therewith.
7. Dates and times of concerts, events, activities, and trips promoted by event sponsors are subject to change and those changes are deemed to be beyond the control of the Station and the Company. Changes of venue, cancellation of engagements by performing artists, and/or their management may be permanent in nature. The Station is not responsible for replacing tickets in the event of show cancellations as a result of weather, promoter or performer. The Station and the Company are not obligated to make any effort to find an alternative prize under these circumstances.
8. Transportation to and from the event venue, souvenirs and incidentals will be the responsibility of the winner and his or her guest.
9. If the winner is a minor (under the age of eighteen (18)), all release forms and affidavits must be signed by the winner's parent or legal guardian.
10. Winners will be instructed to come to the offices of the Station located at 8001 Creedmoor Road, Suite 101, Raleigh, NC 27613. Winners must provide valid identification (e.g. via driver's license, passport or other government-issued I.D. containing the person's name, date of birth, and photograph) to claim their prize. Identification documents must match information previously provided to the Station. If the winner is under the age of eighteen (18) they must be accompanied by their parent or legal guardian who must provide valid identification when claiming the prize.

12. All Contest winners must sign and date official Station release and waiver forms as requested. Failure to do so will result in the winner's forfeiture of the prize.

14. If for any reason a contest winner provides notice that they have decided not to accept an awarded prize, the winner may be required to sign a release form acknowledging forfeiture of the prize. It will be at the discretion of the Contest administrator and / or any Contest sponsor if another contestant is to be selected as the winner if time permits.

In the event any winner is found to be in violation of these Official Rules or is otherwise determined by the Station, in its sole discretion to be ineligible, he/she may be required to forfeit the prize or to reimburse the Station and / or any sponsor for the stated value of the prize if such a violation is found after the prize has been used by winner.

4. Odds of winning depend upon the number of eligible contestants participating during the Contest Period.
5. By participating in the Contest, the winner or winners agree to have their name, voice, or likeness used in any advertising or broadcasting material relating to this Contest, in any media now known or hereafter devised for advertising or promotional purposes without additional compensation, and must sign a publicity release prior to acceptance of the prize. By entering this Contest, each participant agrees to comply with these Official Contest Rules and the decisions of the Station and / or Contest sponsor which shall be final and binding in all aspects relating to the Contest.
6. The Station and the Company retain the right to disqualify any contestant if all Contest rules are not followed.
7. So long as no participant is materially adversely affected, the Station reserves the right to make changes in the Contest rules, which will become effective upon being announced on the air and posted online.
8. All Contest winners will be required to sign a liability release prior to acceptance of any prize. Pursuant to the liability release, the winner or winners will agree to hold the Station, the Company, sponsor, any other Contest parties and each of their respective affiliates, subsidiaries, agencies, officers, shareholders, directors, employees, agents and representatives of each of the foregoing, harmless against any and all claims or liability, directly or indirectly related to or arising from or in connection with Contest participation or the acceptance, possession or use / misuse of any awarded prize or any portion thereof, or participation in prize-related activities, including but not limited to any related travel.

By accepting the prize, the winner acknowledges that the Station and the Company have neither made, nor are in any manner responsible or liable for, any warranty, representation or guarantee, express or implied, in fact or in law, relative to the prize or to any portion thereof, including but not limited to its quality, mechanical condition or fitness for a particular purpose.
10. The Station, the Company, participating sponsors and their respective parent companies, subsidiaries, affiliates or their representatives, agents and employees are not responsible for the inability of any contestant to complete or continue an internet registration, telephone call, or text entry due to equipment malfunction, busy lines, inadvertent disconnections, unavailable network, server, Internet Service Provider (ISP) or other connections, communication failures or human error that may occur in the transmission, receipt or processing of entries, including any injury or damage to any computer arising from or relating to participation in this Promotion. Any use of robotic, macro, automatic, programmed or like entry methods will void all such entries, and may subject that entrant to disqualification. In addition, the Station, the Company, participating sponsors and their respective parent companies, subsidiaries, affiliates or their representatives, agents and employees are not responsible for late, lost, misdirected, mutilated, illegible or incomplete contest entries. No mechanically reproduced or automated entries permitted. Entry materials/data that have been

tampered with or altered are void. Once submitted, entries become the property of the Station and the Company and will not be returned.

If for any reason, the Contest is not capable of running as planned, including without limitation, any suspected evidence of tampering or technological corruption or if any portion of the Contest is compromised by virus, bugs, worms or unauthorized human intervention, fraud, acts of God, strikes, terrorists acts, criminal acts of third parties, an insufficient number of qualified Contest entries, or any other causes beyond the Station and the Company's control which, in the Station and the Company's sole opinion, corrupts, threatens or impairs the administration, security, fairness, integrity, or proper conduct of the Contest, the Station and the Company reserve the right to cancel, terminate, modify or suspend the Contest at their sole discretion.
 13. Any attempt by an entrant to deliberately undermine the legitimate operation of the Contest may be in violation of criminal and civil laws and should such an attempt be made, the Station and the Company reserve the right to seek remedies and damages (including attorney's fees) from any such entrant to the fullest extent of the law, including criminal prosecution.
